# The Judge Larry A. Jones Drug Court



In 1998, Cleveland Municipal Court accepted a federal grant to establish a Cleveland Drug Court. Simply put, drug courts are judicially supervised court dockets that provide a sentencing alternative of treatment combined with supervision for people living with serious substance use.

This specialized docket was presided over by the Honorable Larry A. Jones until his election to the Eighth District Court of Appeals in 2008. In 2009,

The Honorable Anita Laster Mays assumed the position of Drug Court judge and presided over the docket until the end of 2014, when she joined Judge Jones on the Court of Appeals. Following Judge Mays departure, the Honorable Lauren C. Moore took over the docket and continues that role today.

Drug Court may be offered to a felony offender charged with a fourth- or fifth-degree-level possession of a controlled substance, who has only one non-violent felony conviction and is chemically-dependent. Defendants are required to enter a plea of "guilty" to a first-degree misdemeanor. The sentence is held in abeyance pending successful completion of the program. Upon successful completion of Drug Court and payment of a supervision fee, a participant's guilty plea is vacated, the charge(s) dismissed and the case sealed or expunged.

Over 1,900 people have successfully completed the program, which became known as the Greater Cleveland Drug Court since it expanded to a number of suburbs benefitting not just the individuals involved, but also the community in which they live. Average treatment typically costs approximately \$3,000, while the cost of six months of incarceration averages \$14,000.

Because of the program's success, the Cuyahoga County Common Pleas Court formally adopted the program in 2008 and on April 11, 2014 the Greater Cleveland Drug Court received Specialized Docket Certification from the Supreme Court of Ohio.

On October 26, 2022, the Greater Cleveland Drug Court was renamed the Judge Larry A. Jones Drug Court in honor of its first presiding judge. The renaming ceremony took place at Cleveland City Council Chambers, the very place Judge Jones began his political career as a City Councilman in 1981.

## The Honorable Michelle D. Earley Administrative and Presiding Judge



Michelle D. Earley was appointed to the Cleveland Municipal Court on April 20, 2009 and was elected the following November. By a unanimous vote of the Judges in December of 2017, she became Administrative and Presiding Judge making her responsible for the business and overall direction of the Court.

Judge Earley attended The Ohio State University and received a Bachelor of Science degree in Business Administration with a concentration in Information Systems. She then chose to move to Cleveland to attend Case Western Reserve University School of Law.

Judge Earley possesses a strong commitment to the law and the community. Since joining the Court, Judge Earley has presided over the Dedicated Domestic Violence Docket since 2010. She currently presides over the Domestic Violence High Risk Docket.

## The Honorable Lauren C. Moore Judge Larry A. Jones Drug Court Judge



Judge Lauren C. Moore was elected to the Cleveland Municipal Court in 2003 after working as a civil attorney and public defender at the Legal Aid Society, Chief Prosecutor for the City of Cleveland and an Assistant Cuyahoga County Prosecutor.

Since 2005, she's been in charge of the annual *Mock Trial Program*, which has exposed hun-

dreds of Cleveland Metropolitan School students to the legal profession. In January of 2015, Judge Moore took over the Greater Cleveland Drug Court, now called the Judge Larry A. Jones Drug Court, currently one of the longest and most successful programs offered by the Cleveland Municipal Court with over 1,900 graduates.

To those who come before her, Judge Moore inspires people to begin and maintain their journey to sobriety. She also introduced innovative ideas like Therapeutic Recovery Yoga and is an advocate for legislation that prioritizes treatment over incarceration.

## Wayne Dawson Master of Ceremonies



Wayne Dawson is co-anchor of Fox 8 News in the Morning, Cleveland's Number 1 morning show, seen weekdays from 4am to 10am. Before teaming up with the morning crew, Wayne served as co-anchor of the weekend editions of FOX 8 News – rated Number 1 for five consecutive years with Wayne behind the desk.

For two years prior to joining WJW in the late - '70s, Wayne was an anchor/reporter at WNIR Radio in

Kent, Ohio. The 1979 graduate of Kent State University holds a bachelor of arts degree in journalism.

An eleven time Emmy winner, Wayne is a member of the NAACP, the National Association of Black Journalists and the Phi Beta Sigma fraternity. He is also a member of the Broadcasters Hall of Fame. In 2014 Wayne was inducted into the NATAS Silver Circle and also received the Chuck Heaton Award for the Cleveland Press Club. He was also awarded the William Taylor Alumni award from the Journalism and Mass Communications School of Kent State University.



## Joe Brady Keynote



Joe Brady has spent the majority of his working career helping manufacturers and distributors across the country improve their bottom line through the implementation of best-in-class supply chain practices, however personal circumstances compelled Joe and his wife Karen to get actively involved in helping those with Substance Use Disorder. His two daughters struggled with it and one, Brianna died from an accidental overdose in 2021. Brianna was 24 and the mother of two children.

Prompted by these experiences and having met so many people in recovery, Joe launched Unicorns & Polka Dots. His mission and vision is simple – to help those in recovery to identify and implement the very best life skill resources and hobbies that will provide purpose and upward mobility and fill the gaps and voids that come to life in the recovery process.

Unicorns & Polka Dots has already made significant progress and this fall Joe will be launching a recovery council comprised of five men and five women with one to five years of sobriety. Joe will use this council to serve as his eyes and ears out there on the front lines, working to further clarify where the gaps exist and what more can be done to improve the recovery process.

## Jennifer Halstead



Jennifer Halstead worked as the Manager of Mom's House, a sober living community of pregnant women battling opioid addiction. The program began in 2021 designed to welcome pregnant women that other sober living programs turned away, with the goal being to provide a clean, safe place for them and their babies to live and make a fresh start.

Jennifer was one of those moms. During her pregnancy,

she was diagnosed with rheumatoid arthritis and prescribed opioids, which lead to street drugs, heroin and ultimately an arrest and conviction for her involvement in a bank robbery. After four years in prison, she ended up using again.

Jennifer's path to recovery was a long a difficult one and she's grateful for the courts and the people around her that got her to where she is today. "Hearing stories similar to mine and how their lives are changed gave me hope and today I can use some of my darkest moments to encourage others."

## Judge David T. Matia



Judge David T. Matia has served as a judge for Cuyahoga County Common Pleas Court in Cleveland, Ohio since 1999. He started Cuyahoga County's first felony drug court in 2009 and is deeply committed to improving recovery opportunities for individuals both in and out of the criminal justice system.

He has been quoted in the New York Times and featured in Cleveland Magazine and the American Bar Association Journal for his efforts in fighting the heroin/opioid epidemic. Judge Matia is a frequent speaker on the topics of drug courts and the overall opiate crisis. His Court is now referred to as the MAT Court which stands for Medical Assisted Treatment.

### Judge Joan Synenberg



Judge Joan Synenberg has served on the Cuyahoga County Common Pleas Court for the last 16 years. Along with her general criminal and civil caseload, she has presided over several specialized dockets. She oversees the dual diagnosis Recovery Court docket that treats those with mental health and substance

issues, and previously managed a mental health and developmental disability program.

Judge Synenberg also conducts a Pro Bono Collaborative in her courtroom every month which provides free, legal civil assistance to those already facing criminal charges. This could be help with issues such as expungements, driver's license suspensions, collections, evictions/Foreclosures, child support, and child custody/visitation.

## Judge William T. McGinty



Judge William T. McGinty was elected to the Cuyahoga County Common Pleas Court in 2018 after serving as Law Director in Fairview Park and partner in the law firm *McGinty, Hilow and Spellacy*, a practice focused on criminal and juvenile defense.

In 2022, Judge McGinty was selected to oversee the Hope Court, (Helping Others

Prosper Everyday) Court is one of the Court's four Drug Courts. It was created to provide additional opportunity for those who are at high risk of re-arrest, have longer criminal histories and struggle with moderate to severe substance use disorders.

Judge Kelly A. Gallagher was elected to the Cuyahoga County Common Pleas Court in 2016 filling the seat vacated by retiring Judge Jose Villanueva in the court's general division. Shawn's heavy drug usage and flawed decision-making caused him to repeatedly find himself on the wrong side of the law.

On October 4th,1995 at the age of 20 years old, Shawn was driven and motivated by the pain and frustration of his lifestyle and was forced to try a Drug and Alcohol inpatient treatment program. Shawn then became a participant in the Alcoholics Anonymous twelve-step program where he found a sponsor and began working the twelve steps in an attempt to recreate his life.

Shawn journey includes speaking engagements in London England, Bellingham England, Scotland, Ontario, Sweden, and various locations within the United States. Shawn is also the co-founder of the non-profit agency "12 Step Life" which provides credit repair, treatment referrals, permanent housing assistance and sober living for drug and alcohol-dependent persons.
